- * Updated, signed and stamped immunization records; health records must be dated after 8/10/15
- * If you do not immunize your child, a notarized letter of Immunization Exemption is required
- * Child Medical History Information form
- * Signed Parent Information Agreement stating that you have read and agree to rules and guidelines
- * If your child is to be picked up by anyone other than a parent or guardian, a permission slip is required

If there are any restrictions as to whom your child is to be released to, it is necessary to notify us in writing as well as the camp supervisor. This written statement will be kept on file at the site to make certain that the proper procedures are implemented. We thank you for your cooperation in this matter
