1) Fees required within the schedule shall include the review of requisite plans and not more than two compliance inspections, *with the exception those noted below in #2 & #3*. If additional inspections are necessary due to inaccurate submissions, improper installation, defective equipment, *incomplete installation, or as determined by the Chief Fire Marshal*, an additional fee, equal to the original application fee, shall be required, which shall permit not more than two additional inspections.

2) Fire Sprinkler - review of requisite plan, one (1) rough piping inspection (if required), not more then two (2) compliance inspections. If additional inspections are necessary due to inaccurate submissions, improper installation, defective equipment, incomplete installation, or as determined by the Chief Fire Marshal, an additional fee, equal to the original application fee, shall be required, which shall permit not more than two additional inspections.

3) Fire Service Main - review of requisite plan, one (1) prebackfill inspection per 500 feet, (1) one site inspection to witness 200 lbs pressure test, pipe flush and flow test (must be conducted during same visit). If additional inspections are necessary due to inaccurate submissions, improper installation, defective equipment, incomplete installation, or as determined by the Chief Fire Marshal, an additional fee, equal to the original application fee, shall be required, which shall permit not more than two additional inspections.

4) Alterations & New Construction: Fees are calculated based on square footage of all stores.
