New York State law requires all dogs 4 months or older to be licensed and to have their license renewed each year. Dog owners are required to have a dog license tag attached to the dog’s collar. Dog owners with multiple dogs must license them individually. License is valid for one year. If applicant is younger than 18 years old, a parent or legal guardian shall be named the owner of record and the information must be completed by them.

***Applications for ownership transfer must be accompanied by a written statement from the current owner of record acknowledging the transfer to the new owner.**
