## **GENERAL INFORMATION AND FILING REQUIREMENTS**

### Authorization for Certificate of Cancellation

Subdivision 3 of Section 306 of Article 25AA of the Agriculture and Markets Law provides that an eight year commitment, filed as a prerequisite to filing an application with the assessor for an agricultural assessment, shall become null and void upon inclusion of such parcel(s) in an agricultural district formed pursuant to that law. Upon inclusion of such parcel(s) in an agricultural district the conversion and payment provision for parcel(s) within an agricultural district (as set forth in Section 305 Subdivision (1)) will apply to such parcel(s). This subdivision further provides that the owner of such parcel(s) shall file a certificate of cancellation with the County Clerk.

### Place of Filing Certificate

The certificate of cancellation must be filed with the County Clerk of the county in which the agricultural district is formed.

### Time of Filing Certificate

The certificate of cancellation shall be filed with the County Clerk upon inclusion of agricultural lands subject to a preexisting commitment in an agricultural district.

### Description of Land

The description must set forth the acreage, location and boundaries of the land as described in the preexisting commitment.
