A complete Mastic Beach Dock or Town of Brookhaven Mooring application under the Town Code of the Town of Brookhaven must include:

1. A signed and completed application.
2. The complete fee as required.
3. A copy of the vessels' registration or documentation papers.
4. An accurate description of the mooring system (if requesting a mooring permit) to be employed indicating the type and weight of the anchor, the length of the chain, and the size and type of the mooring buoy (form included); or an accurate description of the dock (size and width).
5. The exact location of the dock or mooring placed on a navigational chart, map or survey. Must include a verbal description as indicated on the application form. Mooring applications must indicate the longitude and latitude of the mooring location.
6. A notarized affidavit of indemnity signed by the applicant.
7. Proof of residency (a copy of a tax bill).
8. A statement of authority (completed owner's consent form) from the applicant for any agent making application, if applicable.
